

Affected by earthquakes and volcanic eruptions though not as frequently but as equally devastating


Emerging transboundary threatsepidemics/pand emics terrorism, sargassum,climat e change






Focus on the ACP-EU NDRM Program

Lessons learned

Interventions need to be better aligned to national and regional pririorities established including making a direct contribution to targets and indicators.



- Sufficient time and financial investment is required to bring about meaningful change. Demonstration projects and pilot actions need to be upscaled and be more focused
- There is insufficient real engagement with regional entities who have been given the mandate to lead the DRR/CCA agenda. Resources are no t being optimised.
- Direct funding to specific national priorities is a necessary component of funding streams
- Suffiicient time must be provided for country-level gestation.
- □ The overal focus on contributing to sustainable development and resilience building is critical and not just integration of DRR/CCA.
